

# Westside Property Individual Use Request



The Westside property is privately owned and managed land. Anyone interested in using the property for individual use as a guest must apply with this form and be authorized by TEDA, Inc. prior to use. This pertains to all individuals and all activities, including but not limited to hiking, jogging, riding horses, bicycling and operating motorized vehicles.

To be considered for approval, please fill out this **Individual Use Request** form and a **General Waiver and Release of Liability** submit them to the Receptionist at TEDA, Inc.'s front office. You will also be required to present a valid California State ID such as a Driver License or Identification Card for photocopy. If your request is approved, you will be registered **but still required** to notify **Tribal Security at 209.928.5911** of your intended presence and activity at least two hours in advance of every instance you are on Westside property. You must also retain a copy of this signed authorization in your possession while using the property. Registrations must be renewed every 6 months.

TEDA, Inc. management reserves the right to deny anyone use of this privately-owned Westside property without notice even if you are currently registered. Schedules for use of the land may also change without notice and individuals must leave property if asked by Tribal Security or TEDA, Inc. personnel for any reason. We thank you for your understanding.
